

## **Hubert Campbell Charitable Foundation Scholarship Program**

---

Scholarship available to a graduating high school senior interested in pursuing a career in mathematics education, science education or engineering.

Funding for this scholarship is provided by the Hubert Campbell Charitable Foundation.

Goals of the Hubert Campbell Charitable Foundation:

1. To provide scholarships to an accredited program in mathematics education, science education or engineering.
2. To promote the study of education and engineering and the increase of knowledge in these fields of endeavor.

### **ELIGIBILITY REQUIREMENTS:**

1. High school senior
2. Citizen of the United States of America
3. Have at least a 3.0 grade point average (4.0 basis scale) for the 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> and first semester of 12<sup>th</sup> grades
4. Have at least a minimum score on the American College Testing Program (ACT) of 25 in Math, 25 in English and 26 composite
5. Must enroll and be accepted in an accredited program in mathematics education, science education or engineering, requiring four or more years of study
6. Demonstrate a need for financial assistance to make further education possible.

### **TYPE OF SCHOLARSHIP:**

Hubert Campbell Charitable Foundation will award one \$28,000 Scholarship annually. (Payments of \$3500 to be made twice per calendar year for four years.) To remain eligible for succeeding payments, an official grade transcript must be submitted at the end of each completed semester along with an enrollment certificate for ensuing semester. A 3.0 grade point average must be maintained. (Extenuating circumstances may be reviewed by the scholarship committee.)

**DEADLINE FOR SUBMITTAL:**

Deadline for Application is March 25, 2019. The winners will be announced on or before May 3, 2019. This award is contingent upon enrollment in applicant's selected college and acceptance by that college or university.

Please retain a copy of your completed application for your records.

**SUBMITTALS:**

To be eligible, a student should submit the following to the Hubert Campbell Charitable foundation:

1. Application
2. Official transcripts and ACT scores (Minimum scores Math: 25, English 25, Composite 26; attach official score sheet.)
3. Recommendation of teachers (at least two)
4. Essay on career plans (maximum 300 words)
5. Copies of IRS FORM 1040, 1040A or 1040EZ (pages 1&2 only) for both applicant (if applicant filed a return) and parents (both parents if filing separately) for years 2017 and 2018.
6. Proof of United States Citizenship in the form of a copy of one of the following:
  - a. Birth certificate issued by State, county or municipal authority bearing certification
  - b. Previously issued, undamaged U. S. passport
  - c. Consular certification of birth of U. S. citizen abroad
  - d. Naturalization certificate
  - e. Certificate of citizenship

### **ESSAY**

The essay should discuss your interest in teaching or engineering, your major area of study and area of specialization, the occupation you propose to pursue after graduation, your long-term goals and how you hope to achieve them. The essay may also include any other information (including financial) relevant to your career plans. It should be a typewritten or computer-printed essay of no more than 300 words, double-spaced. Your essay should contain a clearly stated objective, have clarity of expression and logical consistency, and should be free of error. Put your name and field of study at the top of the page.

### **OFFICIAL TRANSCRIPT**

Obtain a certified copy of your high school transcript including your courses for the first semester of the 12<sup>th</sup> grade; (attach to Counselor's page). Be sure that your ACT scores are included on the Counselor's page.

### **COLLEGE INFORMATION**

To be eligible for a Hubert Campbell Charitable Foundation Scholarship, applicant must attend one of the following:

1. Teacher Education program accredited by the National College Accreditation for Teacher Education
2. Engineering program at a university/college accredited by the Engineering Accreditation Commission of the Accreditation Board for Engineering and Technology (ABET-EAC) or a Pre-Engineering Program having a working agreement to transfer credits with an ABET-EAC school

An applicant may be disqualified if the proper accreditation board has not accredited the school.
